Taking Consideration your reference no 1 to 8 mentioned above regarding demand of NOC for the post of Adyapak Sahayak in various subjects, the office sanctioned the NOC as per circular and ordinance of 18/02/1985 Kramank /UBK/Surplus/K/1753/1975 to fulfill the post of Adyapak Sahayak.

Conditions :

1. The institution must follow the grading system for the post
2. The sanctioned workload of Adyapak Sahayak is not more than the current workload.
3. If students and workload are not sufficient, the responsibility of the Adyapak Sahayak is on the principal at the time of recruitment.
4. Postgraduate level 55% and Ph.D. NET or SLET is compulsory for the post as per ordinance of 25/08/2005. New Delhi, So, you must follow this condition at the time of recruitment of Adyapak Sahayak other wise no grant is sanctioned.
5. The Selection committee will select the candidate as per grading system of govt circular shi / date. 23/11/1976.
6. The institute will follow the condition about workload of 40 hours for the selected candidate. as per circular WAC/2610 - 1055 KHUGC recommendations.
7. If the appointment is not on the base of provisions of govt. rules and without university recognition the, appointment is not considered as valid.
8. The institute will submit letters, copies of daily new papers page, the grading letters of selection committee and copies of daily work to the office along with the proposal as per office circular kramank /UBK/surplus/K1/89-90/11001/270
9. Without prior permission of competent officer and state government, the institute, will appoint the selected candidate after getting prior permissin as per circular 2/1/199 kramak/UBK DP /V2K 98-99 2008/423
10. The prior permission of the post is valid upto one year. If the process of appointment is not fulfilled, the NOC will be cancelled.
11. The candidate will be not given any kind of benefits for the first five years of his / her appointment. Benefits about salary commission, reimbursement , LTC, peshgi and other financial benefits will not be given to the candidate.
12. After reviewing the work of candidate, he or she ad will be appointed on the salary grade 15600-39100.
13. After five years, the appointment of ad-hoc salary will be finished.

14. After finishing five year of service, the candidate will be appointed on the gradation of 15600-39100. But the pension benefit scheme is not given to him / her as per circular 1/04/2005.
15. If students are not enough or college is closed for any reason, no protection is given to the appointed candidate.
16. The surplus candidate will be given appointment in other institute or re call in mother institution.
17. Both the sides, one month notice or one month fixed pay notice, the appointment will be cancelled.
18. The appointed candidate must follow the duties as per state govt ordinance.
19. Without maternities leave, no leave will be given to the appointed Adyapak Sahayak for the first five years.
20. The appointed Adyapak Sahayak stay at head office.
21. Rs.15 will be given for the duty 8 km and not more than 12 hours, Rs.30 will be given to the duty of more than 12 hours.
22. If the service is not found satisfactorily, the service will be taken as finished without notice.
23. The appointee will strictly follow term and conduction of state govt.
24. Professional tax will be deducted from fix salary.
25. No rights of higher grade salary are given for first five years.
26. The acceptance letter of appointee regarding condition will be taken.
27. This appointment will be based on appropriate qualification.
28. If service is found satisfactorily for first two years, it will be continue.
29. The candidate must follow suggestion and notice from time to time.
30. The candidate who has UGC recognized NET / SLET / Ph.D. degree will be given Rs.7500 ad hoc salary.



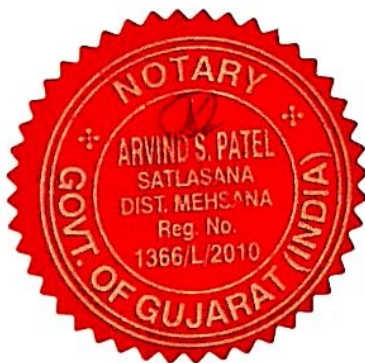
